## NABISCO<sup>®</sup> BIG GAME SWEEPSTAKES OFFICIAL RULES

## NO PURCHASE OR SCAN NECESSARY TO ENTER. MAKING A PURCHASE OR SCANNING WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The Nabisco<sup>®</sup> Big Game Sweepstakes ("Sweepstakes") is sponsored by Mondelēz Global LLC ("Sponsor"), 100 Deforest Avenue, East Hanover, NJ 07936 and is administered by Twelve Thirty, LLC ("Administrator").

- 1. SWEEPSTAKES PERIOD: The Sweepstakes begins at or about 12:00 AM (midnight) Eastern Time ("ET") on January 12, 2024 and ends at 11:59:59 PM ET on February 13, 2024 ("Sweepstakes Period"). The Administrator's computer is the Sweepstakes official clock.
- 2. ELIGIBILITY: This Sweepstakes is open only to residents of the 50 United States and the District of Columbia, or such residents stationed overseas with an address in the 50 U.S./D.C. who are: (a) active-duty U.S. military personnel, veterans, or family of active-duty U.S. military members/veterans; (b) authorized Commissary and/or Exchange patrons; and (c) 18 years of age and older as of the time of entry. Employees, officers and directors of Sponsor, Administrator, Defense Commissary Agency ("DeCA"), Army & Air Force Exchange Service ("AAFES"), The Coca-Cola Company, Coca-Cola Bottlers, HMT Associates, Inc., and any of their respective owners, parent companies, affiliates, directors, subsidiaries, representatives, advertising, promotion and production agencies or agents (collectively, the "Sweepstakes Entities") as well as the immediate family members (defined as including spouse, biological, adoptive, and/or step-parents, grandparents, siblings, children and grandchildren, and each of their respective spouses, regardless of where they reside) and household members (whether related or not) of any of the above are not eligible to enter or win. Void outside the 50 United States/the District of Columbia and where prohibited by law. All federal, state and local laws apply.

Participation constitutes entrant's (and entrant's parent's or legal guardian's if entrant is deemed a minor in the jurisdiction in which entrant resides ["Minor"]) full and unconditional agreement to these Official Rules and Sponsor and Administrator's decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein. Entrants and/or potential winners may be required to provide proof of identification and eligibility as required by Sponsor or Administrator. For purposes of the Sweepstakes, an entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of registration. Entrants will not be allowed to change their physical address or e-mail address on a submitted registration. If it is discovered or suspected that an entrant has registered or attempted to register for the Sweepstakes more than once per calendar day using multiple e-mail addresses, telephone numbers or multiple identities, all of that entrant's entries will be declared null and void and any prize that he/she might have been entitled to win will not be awarded and will be revoked. Use of any automated system or any like methods to participate in the Sweepstakes is prohibited and will result in disqualification of any entrant attempting such use.

3. HOW TO ENTER: During the Sweepstakes Period, an eligible entrant must visit <u>www.NabiscoBigGame.com</u> ("Website") and submit his/her valid e-mail address. An entrant may access the Website directly, or by using a smart phone or other web-enabled device to scan the QR code found on in-store signage. If an entrant chooses to access the Website directly via a mobile device or by scanning the QR code, **standard message and data rates**  **may apply in accordance with their mobile service plan**. A mobile device is not required to enter. If this is the entrant's first visit to the Website, complete and submit the registration form with all required information, which may include, but may not be limited to, first and complete last name (no initials), phone number, street address (no P.O. Boxes will be allowed), city, state, ZIP Code, email address and date of birth. Upon completion and submission of the registration form, the entrant will receive one (1) entry into the Sweepstakes. On subsequent visits to the Website, the entrant need only provide his/her valid email address, i.e., the email address provided upon registration.

Each calendar day thereafter during the Sweepstakes Period the entrant may return to the Website and enter their valid e-mail address, to receive one (1) additional entry into the Sweepstakes.

The Sweepstakes Entities are not responsible for lost, late, stolen, damaged, incomplete, invalid, unintelligible, garbled, delayed or misdirected entries – all of which will be void. Sponsor reserves the right to disqualify any entrant who violates these Official Rules in its sole and absolute discretion.

**LIMIT:** There is a limit of one (1) entry per person/e-mail address per calendar day during the Sweepstakes Period. A "day" is defined as starting at 12:00 AM ET and ending at 11:59:59 PM ET on each calendar day during the Sweepstakes Period.

4. RANDOM DRAWING: On or about February 14, 2024 the Administrator will select one (1) potential Grand Prize winner and eight (8) potential First Prize winners in a random drawing from among all eligible entries received during the Sweepstakes Period. Each selected entrant is considered a potential winner pending verification of eligibility and compliance with these Official Rules.

## 5. PRIZES, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:

- **a. Grand Prize (1):** The "Grand Prize" consists of one (1) \$250 Commissary gift card and one (1) \$250 Exchange gift card. No more than one (1) Grand Prize will be awarded. The ARV of the Grand Prize is \$500.
- b. First Prizes (8): Each First Prize consists of one (1) \$50 Commissary gift card and one (1) \$50 Exchange gift card. No more than eight (8) First Prizes will be awarded in the Sweepstakes. The ARV of each First Prize is \$100.
- c. Total ARV: The total ARV of all available prizes in the Sweepstakes is \$1,300.
- **d.** Odds of Winning: The odds of winning a prize depend upon the total number of eligible entries received during the entire Sweepstakes Period through both entry methods combined.
- e. General Prize Conditions: There is a limit of one (1) prize per person/household. Details of prizes not described herein will be determined by Sponsor in its sole discretion. Each gift card is subject to the policies, terms and conditions of the issuer, which may be printed thereon. If, due to human or other error, the number of prize notifications issued for either prize exceeds the intended number of such prizes, as stated above, the Sponsor will select the winners of the stated number of prizes in a random drawing from among all recipients of such notifications.

6. HOW TO CLAIM A PRIZE: Potential winners are subject to verification of eligibility and compliance with these Official Rules. Each potential winner will be notified by e-mail with instructions on how to claim their prize. All potential winners (or their parents/legal guardians if winners are Minors) may be requested to provide additional documentation for verification purposes within a specified time period. If a potential winner (or his/her parent/legal guardian if potential winner is a Minor) is disqualified, found to be ineligible or not in compliance with these Official Rules, fails to timely provide any requested additional documentation, or declines to accept a prize, the prize may be forfeited. Sponsor will attempt to notify each potential winner as set forth above, but Sponsor is not responsible for any undelivered e-mails, including without limitation e-mails that are not received because of a winner's privacy or spam filter settings which may divert any Sweepstakes e-mail, including any winner notification e-mail, to a spam or junk folder.
